Photography Tips

Think creatively when taking photographs of your project. Try shooting from different angles to show off the special features of your project. Having direct comparison shots of the "before" and "after" views are also a good idea.

Photos of your project should not contain views of people or animals.

Selection Process

The decision of the panel on Ultimate Projects, and the photographs to be shown on the website, will be final. Selected photographs may be cropped or cut at Valspar's discretion.

In addition to the photographs of your project, please include (i) a short description (< 100 words) of the makeover and your use of Cabot Stain, and (ii) the following information: Your name, address, city, state, zip code, and daytime and evening phone numbers. Only your first name, city, and state will be listed on the website.

Selected entries will be featured on our website.

Submission Details

Entries may be submitted by e-mail or by regular mail. All entries become the property of The Valspar Corporation and will not be returned. Valspar is not responsible for lost, damaged, or misdirected entries. Any misrepresentation or false entry information will result in immediate disqualification.
